

#### Performance summary:

- 41,436 participants have entered the Scheme (incl ECEI) since July 2013. 40,496 of these continue to be active.
- 21,196 active participants are receiving supports for the first time.
- In the current quarter, 1,535 participants have entered the Scheme and there are 545 children with initial supports in the ECEI gateway at the end of June 2021.
- 6,301 plans have been reviewed this guarter.
- 2,288 access decisions have been made in the quarter, 1,677 of which met access and are still active as at 30 June 2021.
- 170 (11.1%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in WA to 2,954 (7.4%).
- 141 (9.2%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD), taking the total number of CALD participants in WA to 3,439 (8.6%).

<sup>\*\*\*\*</sup> The logic used to measure these PSG timeframes has changed based on the use of new interactions in the CRM system. The result for PSG5 and PSG11 for the June and March 2021 quarters uses the new logic. Despite current underachievement of PSG 11 regarding facilitating scheduled reviews, the NDIA's new participant check-in process ensures that every scheduled review begins with a contact from the planner or partner to discuss review options well before any scheduled review date.

<sup>\*\*\*\*\*</sup> The target timeframe for PSG 6 has been reduced from 70 to 56 days in early 2021. The result for the June and March 2021 quarters are based on the 56 day timeframe.



- The number of active providers at the end of June is 2,053, growing by 8% in the quarter.
- Utilisation was 69% in the six months from 1 October 2020 to 31 March 2021, with 8% of service districts in Western Australia more than 10 percentage points below the adjusted national benchmark.
- In 25% of service districts, the top 10 providers provide more than 85% of payments.

#### Distribution of service districts by market concentration






## **Service District Summaries**





- Utilisation (as at 30 June 2021)

- North East Metro has the highest number of active participants (6,403), while Goldfields-Esperance has the lowest (642).
- · Central North Metro has the highest average annualised committed supports.
- North East Metro has the highest utilisation at 72%, whilst Kimberley-Pilbara has the lowest utilisation at 51%.
- Only utilisation of committed supports from 1 October 2020 to 1 March 2021 is shown, as experience in the most recent 3 months is still emerging.
