

#### Performance summary:

- 60,402 participants (excluding children accessing early connections) have had an approved plan since July 2013. 55,826 of these continue to be active.
- 40,550 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 681 participants have entered the Scheme in the March 2024 quarter and net participants leaving the Scheme are 354, reflecting active participant movements in and out of the Scheme and South Australia.
- 3,718 plans have had reassessments this quarter.
- 1,221 access decisions have been made in the quarter, of which 1,021 met access and are still active.
- 70 (10.3%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in South Australia to 3,673 (6.6%).
- 37 (5.4%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>4</sup>, taking the total number of CALD participants in South Australia to 3,922 (7.0%).

The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

<sup>1</sup> From the March 2024 quarter, performance is being measured using the available data on processes and dates. Milestones are being built into the new computer system to improve the capture of performance data. Where the performance remains unavailable for this quarter, "n/a" has been substituted.

- Total annualised plan budgets at 31 March 2024 were \$4,345m and payments from 1 July 2023 were \$2,536m.
- The number of active providers at the end of March is 3,455, growing by 3% in the quarter.
- Utilisation has been 77% from 1 July 2023 to 31 December 2023, with 8% (1 out of 12) of service districts in South Australia more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments



#### Service districts more than 10% below plan utilisation benchmark:

• Far North (SA): 63% vs 77% benchmark

### Service districts having between 45% and 70% of payments going to the 10 largest providers:

- Limestone Coast: 56% vs 70% benchmark
- Far North (SA): 52% vs 70% benchmark
- Murray and Mallee: 48% vs 70% benchmark



Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

## **Summaries by Service Districts**



- Northern Adelaide has the highest number (19,078) of active participants, while Far North (SA) has the lowest (595).
- The average annualised plan budget at the end of March for active participants is \$77,800 (\$54,800 for participants not in SIL and \$468,300 for participants in SIL).
- The average payments for the 12 months ending 31 March 2024 are \$61,700 (\$39,800 for participants not in SIL and \$432,700 for participants in SIL).
- · Eastern Adelaide has the highest average annualised plan budgets and payments across all participants.
